This is a team tournament & anglers can fish anywhere in Texas waters. Entry includes t-shirt, Friday night food & drinks, and Saturday lunch at weigh-in.

Team Entry Fee starts at \$600. Registrations received after July 15 are not guaranteed tournament shirts or shirts in size requested.

Tournament Prizes for Heaviest Slot Redfish and Heaviest Legal Flounder

1st - \$1200 2nd - \$900 3rd - \$600

Optional Individual Angler Side Pots - \$50 Each

Sides Pots Pay Out 50% to 1st Place with 50% going to our Endowed Scholarship Fund

<u>Available Side Pots</u>: Heaviest Slot Redfish, Heaviest Black Drum, Heaviest Flounder, Heaviest Combined Stringer (Redfish, Flounder, Black Drum), and Spot Pot (Redfish with most spots)

<u>Lil' Anglers Tournament</u>: Add on a child to your team! - \$100 per child - Children ages 4-12 are eligible (ages 13+ must enter the adult tournament)

Lil' Anglers must weigh in 1 fish to be eligible to win a prize. They must weigh in a redfish, flounder, or black drum. Fish entered into the weigh-in must meet legal limits as determined by Texas Parks and Wildlife to be eligible to win a prize. All children who enter a legal fish into the weigh in will win a prize!

By registering for and participating in the Salty Aggies Fishing Tournament, each participant agrees to be bound by tournament rules.

This release must be signed and turned in BEFORE the start of the tournament July 30, 2022.



Official Tournament Rules

The following are the official Tournament Rules for the 2022 Salty Aggies Fishing Tournament. It is the contestants' responsibility to read, understand, and comply with all the rules outlined below. <u>NON-COMPLIANCE WILL BE GROUNDS FOR DISQUALIFICATION FROM THE TOURNAMENT.</u> By registering for and participating in the Salty Aggies Fishing Tournament, each participant agrees to be bound by Tournament Rules.

- Anglers must be pre-registered to participate, and no registration will be allowed on the day of the tournament. Entry forms must be received online or at the stated address (Nueces County A&M Club PO BOX 6985 Corpus Christi, TX 78466) by stated entry deadline (July 15, 2022 @ 5 pm) to receive stated entry price. Late registrants cannot be guaranteed a T-shirt or swag bag. Late registrants may be received at the Captain's Party at the discretion of the tournament chairperson. Tournament will be held rain or shine – no refunds.
- 2. This is a team tournament. Anglers may fish in any way they choose: by boat, wade, surf, pier, jetty, etc. Fish must be caught on a rod and reel with live, dead, or artificial baits.
- 3. Fishing is only allowed in Texas State waters.
- 4. Tournament T-shirts will be distributed at the Friday Night Captains' Meeting. Each entrant will be given one shirt in the size for which they registered. Shirts will also be distributed Saturday and must be picked up at the event and will not be mailed unless by written arrangement with the tournament directors.
- 5. Winners must be present for raffle prizes and silent auction prizes on Friday night.
- 6. Anglers must be present at weigh in to be eligible for prizes on Saturday.
- 7. This tournament focuses on fun and fundraising for the club. <u>Professional anglers and/or</u> <u>full-time fishing guides may be hired by registered participants but CANNOT fish themselves. If it is determined a professional angler/guide service has fished or provided a registered participant with a gualifying fish, the registered participant(s) will be disgualified.</u>

8. Tournament fishing times are 6am to 4pm Saturday July 30, 2022 No Captain's Meeting or check-in required prior to fishing. Liability waivers must be signed by all participants prior to 6 AM on Saturday July 30, 2022 in order to participate in the tournament. Failure to sign a liability waiver does not negate personal liability.

The fish weigh-in location is at Marker 37 Marina, 13317 S Padre Island Drive, Corpus Christi, TX 78418. Weigh-in will open at 2 PM and close at 4 pm CST. Anglers must weigh in their fish between 2 PM and 4 PM or be in line with their fish at 4 PM in order to qualify for tournament prizes or side pot prizes. The last person in the weigh in line at 4 PM will be identified according to the tournament director's watch and no subsequent fish may be entered.

- 9. All state and federal laws must be observed. Fish must be of legal size according to Texas Parks & Wildlife Department (TPWD) regulations. Anglers may not enter Trout in at weigh-in. No oversized/tagged Redfish may be entered in the tournament. Each fish is eligible for both the tournament prize and one side pot prize if the angler is entered in both. One fish cannot be entered in multiple side pots.
 - a. Legal Fish Sizes according to TPWD for weigh-in eligible fish:
 - i. Redfish: 20"- 28"
 - ii. Flounder: 15" min
 - iii. Black Drum: 14" 30"
- 10. The winning fish in 1st through 3rd place category will be the heaviest fish by weight in pounds as determined by the tournament weighmaster.
- 11. The three-winning fish (Redfish & Flounder) will be awarded tournament prizes as follows (1st Place \$1200, 2nd Place \$900, and 3rd Place \$600).
- 12. Side pots The heaviest fish caught by an angler entered in the side pot will be awarded 50% of the side pot entry funds in that side pot.

-The heaviest combined stringer side pot will be awarded in the same manner - heaviest combined stringer consists of one (1) of each fish in the stringer - Redfish, Flounder, and Black Drum.

*A 3 species stringer will take priority over a stringer with 2 or less species. A lighter 3 fish stringer (with 1 of each species) will beat a heavier 2 fish stringer (with only 2 of 3 species in the stringer).

-The Redfish with the most spots will be awarded in the same manner.

- 13. The tournament weighmaster will be a professional fish handler hired to weigh in fish. If, in his/her opinion, any fish entered in the tournament was caught outside tournament fishing hours or was tampered with in order to alter weight or length, the angler entering the fish in question is subject to disqualification at the discretion of the tournament director. All decisions by the weighmaster and tournament director are final.
- 14. All protests, objections, or suspicions of violations of Tournament Rules must be provided to the tournament director in writing prior to announcement of the winners promptly at 4:30 PM CST. Failure to provide timely written notification will be grounds for dismissal of the objection.
 - a. It is each participant's responsibility to be knowledgeable regarding these rules. Ignorance of a rule is not an excuse.
